PRIVACY POLICY

This Privacy Policy has been created in order to demonstrate the commitment of Flip media Ltd to privacy. We provide this Privacy Policy to inform you what information we collect about you, how we obtain your information and how we use your information.

For the purposes of this Privacy Policy, "we", "our", and "us" refer to Flip media Ltd, "this website" refers to https://www.theflip.io/ website, our mobile website and "you" and "your" refers to a specific individual accessing the website.

Data collection

The information we may collect from you includes:

- 1. Information establishing your identity: for example, name and email address collected through our website registration and order form.
- 2. Financial information: for example, bank account and credit card details.
- 3. Demographic and profile information: for example, age, gender or nationality.
- 4. Information relating to your use of this website: for example, domain name, IP address and cookies. We use your IP address to help diagnose problems with our server, and to administer our website https://www.thenationalnews.com/. Your IP address is or may be used to help identify you, to track activity within our website and to gather broad demographic information. Our Web server will collect IP information. Our website also uses cookies to keep track of your session ID. We may use cookies to deliver content specific to your interests.
- 5. any information you independently choose to provide to us (for example, if you send us an email).

How we obtain your information

We may collect your information during the course of our relationship with you and will only use your personal information in accordance with applicable data protection laws.

We may obtain this information from a variety of sources, including:

- from you (for example, when you access and register on our website, when you
 make an inquiry, send emails, or otherwise provide us with your personal
 information);
- 2. from suppliers; and
- 3. from advertisers, publishing or marketing companies.

How we use your information

We may use or process your personal information for the following purposes:

- 1. To provide you with information about our services and events or other products and other information that we think may be valuable to you.
- 2. To personalise our services and content to you and your geographic region (including, but not limited to, news, advertisements and promotions).
- 3. To respond to any queries, requests, or comments that you may have.
- 4. To process your payments. Financial information that is collected from you is used to check the user's qualifications for registration and to bill the user for products and services.
- 5. To review, develop and improve the services which we offer.
- 6. To comply with our legal obligations.

On what basis we use your information

We use your personal information on the following bases:

- 1. because the information is necessary for the performance of a contract with you or to take steps at your request to enter into a contract;
- 2. because you have given your consent (if we expressly ask for consent to process your personal information, for a specific purpose);
- 3. you have made your personal data publicly available; and
- 4. to comply with legal and regulatory obligations.

With whom we share your information

We will only disclose or transfer your personal information for the purposes set out in this notice to:

- 1. Third party service providers and sub-contractors who provide a service to us (including, but not limited to, marketing and advertising, data processing, IT and office services). Demographic information may be shared with advertisers on an aggregate, anonymised basis. Aggregate basis means that your information will be generalized with the data we collect from all our users. For example, we may share the average age of our users with advertisers. However, we will not share any personal information (i.e. any information that can relate to an identified or identifiable individual), such as contact information, financial information and demographic information, with advertisers about any particular individual that uses our websites.
- 2. Any member of our group.
- 3. Any competent authorities if we are legally required to comply with a request for data.

Countries to which we transfer your information

The information you submit may be transferred, stored and hosted outside the United Arab Emirates or the country from which you may be accessing this website, and may be

transferred to countries which do not have data protection laws or to countries where your privacy and other fundamental rights will not be protected as extensively. These and all other transmissions will remain secure and under our sole control.

We will implement appropriate measures to ensure that your personal information remains protected and secure when it is transferred outside your home country and you can exercise your rights effectively.

Data retention

We will keep your data only for as long as is necessary to respond to any queries or complaints, to improve the services that we offer to you or to comply with any legal obligations to which we may be subject.

To determine the appropriate retention period for personal information, we consider the amount, the nature, and sensitivity of the personal information, the potential risk of harm from unauthorised use or disclosure of your personal information, the purposes for which we process your personal information and whether we can achieve such purposes through other means, and the applicable legal requirements.

Your rights

- 6. Receive or transmit your data in a machine-readable and structured format (otherwise known as "data portability") request the receipt or transmission of your personal information to another organisation, in a structured and machine-readable format; and
- 7. Withdraw your consent withdraw your consent at any time to the use of your personal information for a particular purpose (where we have asked you for consent to use your information for that particular purpose).
